Early Momentum Metrics Report

Purpose of the Report:

- Annual report created by Institutional Research, based on metrics developed by the Community College Research Center (CCRC) at Columbia University.
- Measures early indicators of student progress and potential for on-time completion.

Metrics Tracked:

• Completion of 6+ credits (1st term), 12+ credits (1st term), 15, 24, and 30+ credits (1st year), College-level math and English (within 1st year), Persistence from fall to spring

Cohort:

- First-time full-time and part-time students.
- Data covers the past five years, with the most recent being Fall 2024.

Key Findings:

- Black students showed improvement in 7 out of 8 metrics from Fall 2023 to Fall 2024.
- Students in both Developmental Education English and Math showed improvement across all 8 metrics.
- Other groups (Hispanic, White, all students) had less consistent improvements.

Discussion Points:

- Why is there improvement?
 - o Could be due to annual variability or cohort differences
 - Questions raised about factors like age, high school background, or part-time/full-time ratio

Metric Limitations:

- Metrics include grades A–D for credit (not necessarily course success).
- Full-time vs. part-time proportions may influence outcomes.
- Comparisons affected by small cohort sizes and COVID-era data skew.

Need for Deeper Analysis:

- Suggested to disaggregate data further by:
 - o Race/ethnicity, Pell eligibility, age, program type (credit vs non-credit).
 - o Involvement in support programs (e.g., TRIUMPH/SURGE participation data).
 - o Consider shifting from outcome-first analysis to intervention-based tracking.

Actionable Takeaway:

- Growing interest in linking data to interventions.
- Calls for refining metrics and expanding data collection (involvement, basic needs, demographics).
- Research team will provide additional requested data for a follow-up discussion at the December Operational Assembly meeting.
