Tuition Payment Schedule



Registration begins on **Oct. 29, 2018**. Registering early gives you the best selection of classes, can significantly reduce the wait time to see a counselor, and allows you to set up a payment plan that gives you up to six (6) months to pay for classes. Register online through the MyTriton portal, in person at the Welcome Center, or by phone with the Call Center. Once you register for classes, you must make payment arrangements (see options below).

If you register between...	Tuition Payment Deadline
Oct. 29, 2018-Jan. 2, 2019	Jan. 4, 2019
Jan. 3-May 17, 2019	Within 2 days

If you do not make payment arrangements within the specified timelines, you may be dropped from your selected classes. The College will send an email to your official Triton College email address notifying you of the need to re-enroll. **If you decide not to attend, please remember to that you must drop courses for which you have registered. Otherwise, you will be responsible for all tuition and fees.**

The following PAYMENT OPTIONS are available to students.

- **Payments in full** may be made by cash, money order, check, or credit card (MasterCard, Visa, or American Express) at the Cashier's Office (Student Center, Room B-130). You may also pay online through your MyTriton portal.
- **Proof of 3rd party payment** a 3rd party (e.g., your employer) providing payment on your behalf.
- **FACTS Payment Plan** - Interest-free monthly installments to be automatically deducted from your bank account or credit card
 - o Program eligibility requires a minimum balance due of \$250 and a \$25 processing fee. A valid bank account or credit card is needed to set up the payment plan.
 - o Apply online through your MyTriton portal.

- **FACTS Pending Aid Payment Plan** - Available for eligible students who have an expected family contribution (EFC) of \$4,900 or less (based on the FAFSA on file in the Financial Aid Office)
 - o The \$25 FACTS processing fee is deferred until the plan is activated. If your financial aid award covers all institutional charges, the plan is canceled with no penalty.
 - o If you have an incomplete file or a balance due after the financial aid award has been applied to your account, you may pay the balance due in a one-time payment and cancel the plan with no penalty. Otherwise, the \$25 FACTS processing fee along with the first of three monthly installments will be charged beginning on **March 5, 2019**.
- **Financial Aid holds** will be applied if you have completed the financial aid application and have been awarded grant funds for the fall term. You are encouraged to sign up for a payment plan if you have a balance remaining after financial aid has been applied.

Due to FAFSA processing time (usually 3-5 days), you may request a **one-time protective hold (up to 7 days) in the Financial Aid Office** if you register and complete the FAFSA on the same day.
