Karlin suggested checking the 'Learn Information Literacy' box under the 'General Education Outcomes', as the research paper would count as an outcome. M. Flaherty concurred with K. Karlin's suggestion.**

Misasi Maratto will search the College Catalog or all coordinators and chairpersons will need to review in their areas.
